

## **Suzuki Lightning Conversions Guarantee:**

- Unless otherwise stated, all parts come with a 90 day guarantee.
- Electrical parts are guaranteed 90 days. Exchanges of electrical parts that become faulty within 90 days are accepted for identical replacement only. Electrical parts may not be returned for refund or store credit. An electrical part that becomes faulty may not be exchanged for a different part.
- Suzuki Lightning Conversions has no responsibility for the diagnosis or troubleshooting of a problem. The responsibility of ordering the correct part remains with the customer and his technician.
- Suzuki Lightning Conversions guarantees the part shipped to be suitable for the make, model and year of the requested application.
- Suzuki Lightning Conversions only guarantees Partial Conversion Kit parts to fit correctly when used in conjunction with the entire Suzuki Lightning Conversion V6 conversion kit.
- All deposits are non-refundable.

## **Payment Policy:**

- Suzuki Lightning Conversions accepts Visa, Mastercard, American Express, Discover.
- In the event of an order in excess of \$1000, we request an invoice be faxed, signed and returned.
- All deposits are non-refundable.

## Return policy:

- All Deposits are non-refundable.
- Returns are for store credit ONLY.
- Returns may be made up to 30 days of the order date, and are subject to a 20% restocking charge.
- Return authorization # must be on the outside of the box.
- A copy of the invoice must be included with a note describing the reason for the return.
- All returns must be shipped freight prepaid. cod or freight collect returns will not be accepted.
- Suzuki Lightning Conversions has no responsibility in the diagnosis or troubleshooting of a problem. The responsibility of ordering the correct part remains with the customer and his technician.
- Suzuki Lightning Conversions liability due to a defective part is limited to the value of the part only. We will not be responsible for labor costs, downtime, freight costs, or any other associated costs, for any reason.
- Exchanges for parts that become faulty prior to the end of the guarantee period must be shipped to Suzuki Lightning Conversions at the customers expense. the replacement will be shipped at Suzuki Lightning Conversions expense.
- Electrical parts are guaranteed 90 days. exchanges of electrical parts that become faulty within 90 days are accepted for identical replacement only. electrical parts may not be returned for refund or store credit. An electrical part that becomes faulty may not be exchanged for a different part.
- Special order items such as body or frame cut off sections are not returnable for either refund or store credit.

## Suzuki Lightning Conversions Limited Warranty:

- All crated kits are sold in exchange for the customers old parts (engine, transmission, and all parts removed to install the v6 conversion) The crate and old parts are to be shipped back to Suzuki Lightning Conversions at our expense. This step must be completed to activate the warranty.
- Ninety (90) days on the engine provided that the fault which occurs is not the fault of the Buyer or a third party other than the guarantor.
- Ninety (90) days on the transmission provided that the fault which occurs is not the fault of the Buyer or a third party other than the guarantor.
- One (1) Year on all the rest of the kit parts limited to replacement of said parts.
- Suzuki Lightning Conversions shall not be responsible for any labor cost incurred when assembling Lightning conversion kits.
- While we at Suzuki Lightning Conversions pay special attention to detail, our converted suzukis pass Florida emissions but it is impossible for us to check them in all 50 states. The responsibility lies with the owner and their tech in their appropriate state.
